

## Refer a Friend Promotion– Terms & Conditions (“Conditions”)

1. The promoter is Travelex Limited ABN 36 004 179 953, AFSL 2244 of Level 12, 1 Margaret Street, Sydney NSW 2000, Australia, (02) 8585 7000 (“**Travelex**”).
2. Subject to clause 9 of these Conditions, entry is open to any person who holds a valid Travelex Cash Passport Card\* purchased in Australia and who makes a referral in accordance with condition 3 and 4 below during the time of this promotion (“**Eligible Entrant**”).
3. The Eligible Entrant must refer a friend (“**Referred Friend**”) to Travelex Cash Passport Card. A referral will be considered to be a successful referral (“**Successful Referral**”) for the purposes of this promotion where the following conditions are satisfied:
  - a. The Referred Friend was not an existing holder of a valid Travelex Cash Passport Card prior to the referral; and
  - b. The Referred Friend purchases a Travelex Cash Passport Card from Travelex during the Promotion Period (“**New Cash Passport Card**”) and load their new Travelex Cash Passport Card at the time of purchase with a minimum initial amount of AU\$3000 (or foreign currency equivalent).
4. To enter this promotion, during the Promotion Period an Eligible Entrant must e-mail the details below to [cashpassport@travelex.com.au](mailto:cashpassport@travelex.com.au) :
  - a. The Eligible Entrant’s name;
  - b. The last four digits of the Eligible Entrants Travelex Cash Passport Card;
  - c. The currency of the Eligible Entrants Travelex Cash Passport Card;
  - d. The Referred Friend’s name;
  - e. The last four digits of the Referred Friend’s New Travelex Cash Passport Card;
  - f. The currency of the Referred Friend’s New Travelex Cash Passport Card; and
  - g. The date the Referred Friend purchased their New Travelex Cash Passport Card.
5. Within 14 days of verifying that the referral is a Successful Referral, Travelex will credit the Eligible Entrant’s Travelex Cash Passport Card and the Referred Friend’s New Cash Passport Card, each with the amount of \$AU30 (“**Credit**”). For the avoidance of doubt, Travelex will provide only the one Credit for each Eligible Entrant and their Referred Friend being for the initial load amount onto the New Travelex Cash Passport Card notwithstanding that the Referred Friend may reload their New Travelex Cash Passport Card with further amounts during the Promotion Period.
6. There is no limit on the number of referrals an Eligible Entrant may make during the time of this promotion.
7. Entry to this promotion is open to all Eligible Entrants between 16 September 2008 and 31 October 2008 (“**Promotion Period**”).

8. Travelex's agents and franchisees and, employees of Travelex and its related bodies corporate, employees of Travelex's agents and/or any of its franchisees are not eligible to enter this promotion.

  - a. Error, omission, interruption, deletion, defect, delay in operation, theft or destruction or unauthorised access to, or alteration of entries; or
  - b. Loss or damage whatsoever (including but not limited to direct or consequential loss) or personal injury however caused including, but not limited to, by their or any of their negligence, suffered by the Entrant or any other person relating to the use or enjoyment of, or non-delivery or non-useability of, a Card Credit.

If for any reason, Travelex is unable to run this promotion as planned, including tampering, infection by computer virus, bugs, unauthorised intervention, fraud, technical failures or any other causes beyond the control of Travelex that corrupt or otherwise affect the administration, security, fairness, integrity or proper conduct of this promotion, Travelex may in its sole discretion disqualify any person who tampers with the entry process, and cancel, terminate, modify or suspend the promotion, subject however to any written directions given under applicable law.
