

Multi-currency Cash Passport™ Australia Bonus Campaign 2017

Multi-currency Cash Passport – Promotion Terms & Conditions of Entry (“Conditions of Entry”)

The minimum load and reload amounts are detailed below and must be loaded or reloaded between 9:00am AEST 14 August 2017 - 11:59pm AEST 31 October 2017 (“**Promotion Period**”) in a single transaction at stores or online at www.cashpassport.com.au and registers their Cash Passport online at <https://www.cashpassport.com.au/more> before 31st October 2017 (“**Eligible Entrant**”). Eligible Entrants will be credited with the amounts in AUD to their Australian Dollar currency wallet on their Cash Passport (“**Bonus**”). All amounts will be credited to Bonus winners within 30 days from a valid registration being received. The Promoter may, in its sole discretion, cancel or vary the promotion and the Bonus at any time. If the Promoter cancels or varies the promotion and the Bonus, it is not liable to any person for any costs, loss or damage whatsoever arising out of, or in connection with, such cancellation or variation and is not required to conduct the promotion at any other time.

The Cash Passport is valid for up to five (5) years but inactivity fees may apply after twelve (12) months of non-usage of the Cash Passport. The total residual fund of the Cash Passport may be withdrawn at any time and will incur a fee depending on the country of activity.
10. Should an Eligible Entrant's contact details change during this promotion, it is the Eligible Entrant's responsibility to immediately notify the Promoter. A request to modify any information provided in an entry should be directed to the Promoter.
