Multi-currency Cash Passport – Promotion Terms & Conditions of Entry ("Conditions of Entry")

- 3. The promotion will be advertised in participating stores and online at www.cashpassport.com.au. Please note that participating stores who make any promotional and related material regarding this promotion available to persons (either in their stores or online) do so on the basis that all such material has been prepared by and remains the property of the Promoter. The total residual fund of the Cash Passport may be withdrawn at any time and will incur a fee depending on the country of activity.
- 12. Should an Eligible Entrant's contact details change during this promotion, it is the Eligible Entrant's responsibility to immediately notify the Promoter. A request to modify any information provided in an entry should be directed to the Promoter.
